PAYMENT OPTIONS

Payment of fees and levies can be made via BPAY, EFT, credit card, direct debit, cash, or cheque made payable to St Mary's Primary School.

Fee statements are issued each term and are due 14 days from issue. Alternatively, a direct debit arrangement can be set up for weekly, fortnightly, or monthly payments. EXPLANATION OF LEVIES

FAMILY CAPITAL LEVY

The family Capital Levy enables the school to continue building and maintaining facilities designed to optimise the learning environment for every student. Families with children also attending St Mary's College receive a 50% discount.

FAMILY P&F LEVY

This levy enables the P&F to coordinate family and community events throughout the year.

TECHNOLOGY LEVY

This levy supports and maintains our technology infrastructure such as our high-volume broadband link, wireless network, interactive projectors, hardware, laptops, iPads, software and support of skilled personnel and services.

GENERAL YEAR LEVY

This levy covers the cost of camps, excursions and other extra-curricular activities (eg swimming lessons) undertaken by the students.

VOLUNTARY LIBRARY CONTRIBUTION

This is a **voluntary** contribution and is utilised solely for library resources. Families that decide to pay this voluntary contribution receive a Library Fund Contribution Statement each financial year and these contributions are tax deductible.

VOLUNTARY PARISH CONTRIBUTION

This is a voluntary contribution and is passed onto the St Mary's Parish as a donation.

St Mary's Primary fees and levies are primarily structured as all-inclusive (some optional extra-curricular activities are not included). We believe this gives parents the security of planning ahead financially with no hidden costs.
